Event Cancellation Policy

Notification of cancellation must be submitted in writing via email to conferences@turnaround.org. Cancellations will not be reviewed or processed until they are received in writing. Phone cancellations are not accepted. Cancellations received on or before **SEPTEMBER 17, 2024**, will be refunded 50% of all registration fees. Cancellations or registrations received after the cancellation deadline of **SEPTEMBER 17, 2024**, will not be eligible for a refund. Refunds will be issued no later than **OCTOBER 29, 2024**.

Substitution Policy

Substitutions are only permitted on the day of cancellation.
