Event Cancellation & Substitution Policy

Substitutions for networking activities are not permitted; however, you may choose a substitute for networking activities if you are substituting your entire registration.

EVENT CANCELLATION POLICY

Notification of event cancellation must be submitted in writing via email to conferences@turnaround.org. Cancellations will not be reviewed or processed until they are received in writing. Phone cancellations are not accepted. Cancellations received on or before January 26, 2026, will be refunded 50% of all registration fees. Refunds will be issued no later than March 2, 2026. Cancellations or registrations received after the cancellation deadline of January 26, 2026, will not be eligible for a refund, though a credit may be applied toward your TMA 2026 Annual Conference (October 27-30) registration. Credits are non-transferable, cannot be redeemed for cash, and are forfeited if the registration is canceled again. Attendees are responsible for any difference in registration fees.

SUBSTITUTION POLICY

Substitutions are only permitted on the day of cancellation. If you cannot find a substitution by the day of cancellation, or if the cancellation occurs after the cancellation policy deadline date, you will forfeit your registration. Substitutions must be submitted in writing via email to conferences@turnaround.org for consideration. Phone substitutions are not accepted. Please note that substitutions made after January 26, 2026, may not be reflected on the registration list. The substitute must be from the same firm as the original registrant, and the substitution notice must contain accurate contact information for the new registrant; otherwise, TMA cannot guarantee an accurate listing on the registration list. Substitute registrants with different membership statuses and/or registration categories will be invoiced the difference in registration fees. The last day for substitutions is January 26, 2026.
